

We give low income and limited English proficiency taxpayers in Vermont free legal help on federal and state tax issues.

HOW WE HELP

Solving IRS Issues

We can help when...

- the IRS holds your refund
- you owe money to the IRS
- the IRS is auditing your tax return
- the IRS is putting a lien or levy on your property or income
- you get a letter from the IRS and aren't sure how to respond.

In most cases, the LITC doesn't prepare tax returns.

The LITC is not part of or endorsed by the IRS. Your decision to call the LITC will not affect your rights before the IRS.

Education

We help you understand your tax rights and responsibilities. We coordinate with community organizations to provide education and outreach.
